

**KJJK "Trip for 4 to a Spa in Fort Lauderdale Florida"
Official Contest Rules**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT
INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**

1. How to Enter the Contest

- a. The KJJK "Trip for 4 to a Spa in Fort Lauderdale Florida", 321 – Jack phone contest will begin on March 15, 2007, at 5 AM Central Time ("CT") and end on March 21, 2007, 4:00 PM CT.
- b. To participate in the contest, call 1-877-321-JACK and follow prompts to leave a comment, complete the call by following the directions. A random drawing of all comments left will be held for the prize pack. Phone numbers are captured by the system used. These numbers will be used to call the winner. Only one entry per person. Station is not responsible for entries not received due to difficulty accessing the 321-JACK, service outage or delays, computer difficulties or other technological glitches. All entries must be received by March 21, 2007 at 4:00 PM CT. Any entry received after this time will be considered ineligible.
- c. ONE ENTRY PER PERSON, PER HOUSEHOLD, AND PER E-MAIL ADDRESS.

2. Eligibility Restrictions
